13. DISPOSAL CONSIDERATIONS

A. Disposal methods

- Since more than two kinds of designaed waste is mixed, it is difficult to treat sepearatly, then can be reduction or stabilization by incineration or similar process.
- If water separation is possible, pre-process with Water separation process.
- Dispose by incineration.
- High temperature incinerate
- After taking off organic solvents that are supposed to be recycled, incinerate the rest of them at a high degree.
